License validity periods:

- one-day license is valid on the date and time specified in the license
- \bullet annual license, discounted annual license and free annual license valid from the date of purchase until December 31 of the current year.

Rules for licensed fishing:

Fishing must be carried out in accordance with the Cabinet of Ministers' 22.12.2015. to regulations no. 800 "Fishing, crayfishing and underwater hunting regulations" and binding regulations of Jēkabpils region municipality no. 2019/15 "Jēkabpils County Licensed Fishing Regulations of Lake Balote" with the following additional restrictions:

- fishing is allowed in the entire territory of Balote Lake, except in the specially defined protection zone, which is fenced off with buoys in the lake;
- one angler may store and keep the following bag limit of fish species on a 24-hour basis:
 - 1. pike, zander, tench three of each species;
 - 2. three carp, the weight of each carp must not exceed 2 kg;
 - 3. fish of other species up to 5 kg of each species;
 - 4. Grass carp and silver carp are not allowed to be kept and have to be released immediately.
- for holders of annual licenses, the number of carp caught per year may not exceed 20 kg;
- during the winter season, from November 1 to March 31, it is forbidden to catch and keep carp from the ice.

Fishing in Lake Balote is allowed from the shore (using a 10-meter towpath), from the ice, from a boat, as well as wading into the water.

It is forbidden to engage in underwater hunting and crayfishing in Lake Balote.

Environmental and natural resource protection requirements

The fisherman is obliged to:

- 1. present a fishing card, ID document, relevant fishing license, fishing tools and catch for control at the place of fishing;
 - 2. treat nature with care, not to pollute the water body and its coastal area;
 - 3. fill in the fishing license catch table.

During the ice period in Lake Balote, it is forbidden to move on the ice with motor vehicles and mopeds.


Catch reports:

All license holders, regardless of their type, must register their catch in the catch report table of the license. Carp caught for keeping and not releasing has to be registered immediately. Fish of other species have to be registered at the end of the day, indicating the date, time, species of fish, size of the catch (number and weight of fish).

Catch report deadlines:

- one-day licenses within 5 days from the day of use;
- annual licenses until January 5 of the following year.

!!The holders of all one-day licenses and annual licenses in cases of not sending their catch reports and failure to provide information about catches, as well as in cases of other types of fishing violations, will be denied the opportunity to purchase or receive any type of license for fishing in Balote Lake in the current and next year.
