Content

1. PART 1 -GENERAL

Definitions

Terms used within the meaning of this Regulation:

Event – a public angling event organised outdoors by the association "Sport fishing" (hereinafter BSM), in which BSM members participate and invited persons,

Cup – Within the frameworkof the event, a test of s fishing skills in catching predatory fish from a boat - spinning or fly fishing technique.

Participant - members of the BSM and invited persons who comply with the requirements in force in the country regarding the regulations for the containment of the spread of COVID-19 in Annex 2to this Regulation.

Boat – two Participants fishing together in the same boat.

Fishing – spinning or fly fishing.

Vessel – a boat at least 3,70 metres long, equipped with a petrol or/and electric motor.

OBJECTIVE AND MISSION OF THE ACTION

- 1.1. to promote fishing as an exciting, active and healthy lifestyle, freely accessible to everyone in Riga and Latvia and to guests;
- 1.2. to facilitate the exchange of experience between MemberStates;
- 1.3. promoting compliance with the catch and release principle;
- 1.4. to promote the protection of Latvia's fish resources;
- 1.5. promote Riga and Latvia as a great fishing tourism destination.

EVENT ORGANIZER

Association "Sport Fishing" Contact person – Evita Zeila, Edgars Deičmanis.

Responsible for the availability of hunting services and implementation of epidemiological safety measures – Evita Zeiļa.

Edgars Deičmanis, who is responsible for compliance with public order, safety regulations and all laws and regulations.

TIME OF THE EVENT

September 17, 2021 – opening of the solemn event and boat parade;
18 September 2021 – the first day of the Cup;
September 19, 2021 – second cup day, closing ceremony.

VENUE OF THE EVENT

Andrejosta Yacht Club, Riga, Latvia

Closed boat pier – opening of the event, start/finish place, awarding of the most masterful lernsets, closing ceremony.

The cup takes place in Daugava, Bullupe, Lielupe, Vecdaugava, Kisezers, Great Baltezers, Mazais Baltezers, Jugla Lake or any natural water body/ watercourse, where you can reach by a vessel from the starting point.

PARTICIPANTS IN THE EVENT

The event is open to BSM members and persons invited by the organiser, residents of Latvia and/or foreign visitors who have reached the age of 18.

JUDGES OF THE EVENT

The judges of the Cup and impartial trial are provided by the outsourced service provider SIA "Latvijas Lauku consultancy and education centre" site "Mana Cope" (hereinafter – Mana Cope). Judges take decisions collegially.

PARTICIPATION FEE, APPLICATION PROCEDURE AND DEADLINES

- 1.6. You can apply for the event 2019.
- 1.7. The application takes place electronically via the My Cope website , the My Cope mobile application, or the website www.manacope.lv, the"Spirit of competition" section.
- 1.8. The crew shall beregistered by one person on both lesand, if necessary, one reservist. After registration, a confirmation, invitation, team number, and Memberan ieka card are sent to the crew contact person specified in the application.
- 1.9. Participation fee and login terms:

- 1.10. Changes in the composition of the Member States may be applied for until10 September 2021.
- 1.11. If the participant who has applied for participationdoes not attend theevent, he or she will be disqualified and the participation fee will not be refunded.
- 1.12.1.12. If a Participant attends the Event but does not have an interoperable disease certificate, or has a long-term impeccable certification certificate or interoperable testing certificate, and does not wish to take the Covid -19 test, he will be disqualified and the participation fee will not be refunded.
- 1.13. Event organizer reserves the right to refuse a Memberbefore participatingin the Event by informing the Participant thereof in writing by 5 September2021.

2. PART — MINIMUM REQUIREMENTS

REQUIREMENTS FOR PARTICIPANTS

- 2.1. The physical abilities, state of health, skills and abilities of the participant allow to participate in the Event.
- 2.2. The Participant applies for the Event, receives an invitation and pays the Participation Fee in full in accordance with the deadlines set out in point 1.9.
- 2.3. For the duration of the Event, the Participant has purchased and valid Angling, Crayoning and Underwater Hunting card or is able to present a document allowing fishing without it.

Members mustprovide themselves with:

- 2.4. charge your mobile phone with internet connection, photography function and installed apps Mana Cope and WhatsApp, thus enabling you to take and send photos and fish release videos for 8h on each Cup day;
- 2.5. the tools, artificial decoys and accessories necessary for fishing for gentle receptionand release of z ivs;
- 2.6. weather-appropriate clothing and footwear;
- 2.7. supplies of fresh drinking water.

COMMITMENTOF PARTICIPANTS

When applying for the Event, the Participantundertakes to:

- 2.8. to pay the D-alityfee set by the organiser within the specified time limit;
- 2.9. comply with and comply with the organiser's requests, instructions and decisions of the panel of judges;
- 2.10. comply with the Regulations of angling, crayoning and underwater hunting (Cabinet Regulation No. 800 of 22.12.2015), Regulations Regarding Vessel Traffic in Inland Waters (09.02.2016 Cabinet Regulation No. 92), Free Port of Riga Regulations (Riga City Council 02.05.2017. binding regulations No. 255), this Regulation, as well as other regulatory enactments in force at the place and time of the venue.
- 2.11. to participate in the Cup without the intention of cheating, otherwiseinfluencing the result;
- 2.12. inform organisers and judges about cases of fraud. Concealing or concealing fraud activities will be equated with the fact of frauditself and will be subject to the same sanctions.
- 2.13. to adhere to the catch and release principle and treat the fish with the utmost responsibility and care.
- 2.14. treat competitors, judges, organisers, venue hosts, third parties and the public with respect.
- 2.15. behave politely and amicably throughout the event, creating a good picture of yourself in 2018,
- 2.16. not to use profanity, indecent gestures, or to perform acts that may cause moral or physical harmto otherMembers, organizers, judges, third parties, or the Member himselforherself.
- 2.17. not to lose, damage issued measuring metals, Member States'cards and protocols
- 2.18. to observe throughout the period of the event that excessive consumption of alcohol or intoxicating substances is strictly prohibited.
- 2.19. not to use public channels of information, including social media, to post comments or complaints that might harm thereputation of eventorganisers, sponsors, judges, partners or other participants. All disputes shall be resolved in person with the organisers.

IT ISPROHIBITED TO TAKE A MEMBER STATE

- 2.20. To participate in the Event under the influence of alcohol (noticeable alcohol intoxication is unanimously determined by the college of organisers and this decision is not contestable).
- 2.21. Apply for registration and send photographs of fish obtained before the Time allotted for the Cup, caught by another person, or caught catching the fish (the hook is behind the gill cover in the body, fin or tail) or otherwise cheat.
- 2.22. Use live or dead natural bait for fishing.
- 2.23. Go fishing without a measuring tape and ID card issued by the organizer.
- 2.24. Move with the internal combustion engine without a life jacket.
- 2.25. Feed or otherwise lure fish.
- 2.26. Use two or more decoys at the same time.
- 2.27. Use more than one spinning or flies at a time.
- 2.28. It is forbidden to fish in trolling or trolling techniques.
- 2.29. Be closer than 50m to other vessels, both those participating in the Cup and those not participating. If another shipping vessel closer than 50m is approaching an anchorage vessel, the Member State shall be obliged to warn it to keep a distance of 50 m.
- 2.30. Interfere in any way with other Participantsparticipating in the Cup.
- 2.31. Situated in the narrow space necessary to move further into the body of water, continue spinning while the vessel is closer than 50m in motion.
- 2.32. Fishing closer than 10m from or below bridge structures.
- 2.33. It is strictly forbidden to fish on fairways.

- 2.34. It is strictly forbidden to anchor in the fairway, as well as to stand near navigational signs and stops, if they are not intended for the relevant type of vessel.
- 2.35. It is strictlyforbidden to leave the boat without co-ordination with the Council of Directs at the time reserved for fishing.

REQUIREMENTS FOR THE VESSEL

2.36. The crew must be provided with a vessel the length of which is at least 3.70 metres, equipped in accordance with the laws and regulations in force and the needs of the Member State andwhich is in good technical order;

VESSEL SAFETY EQUIPMENT

- 2.37. The vessel must be fitted with the following safety equipment:
 - One or two oars;
 - Lifebuoys;
 - Automatic and/or appropriate size or lifejackets for each Member;
 - Emergency ignition switch device;
 - The first aid kit.

SAFETY REQUIREMENTS

- 2.38. Persons who have been determined self-isolation, home quarantine or strict isolation or who have signs of respiratory infection may not participate in the event and are categorically prohibited from being present at the venue.
- 2.39. It is forbidden to crowd, as far as possible, a distance of 2 meters should be observed.
- 2.40. The participants of theevent must comply with all theregulations of the Cabinet of Ministers and epidemiological safety requirements in force at the venue and time of the Event.
- 2.41. Member States shall be solely personally responsible for their safety at/on the water, for compliance with the rules on shipping.
- 2.42. When shipping an internal combustion engine vessel, the Member Statemust wearsafety vests.
- 2.43. If the weather deteriorates during the Cup, there is a thunderstorm, storm, hail, etc., fishing should be stopped, spinning or fly-picking should be placed horizontally in the boat and move closer to the shore to further instructions from the organizer.
- 2.44. Theparticipant's boat security during the event will be provided for those boats that will be parked at the venue in Andrejosta, however, Member statesmust take care of their fishing equipment, its care and its unattended position in a timely and independentmanner.
- 2.45. Organizers are not responsible for the boats, equipment and personal belongings of the event Participant.

3. PART 1 – EVENT

AQATORY

Daugava, Lielupe, Bullupe, Kisezers, Jugla Lake, Lielais Baltezers, Mazais Baltezers, Vecdaugava, Dry Daugava, Sarkandaugava, Milgravis and other public waters that can be accessed from the starting point using a vessel.

DESCRIPTION

- 3.1. The event takes place according to a programme drawn up by the organisers.
- 3.2. The event is organized in such a way as to exclude gatherings as much as possible, with the participants spendingmostof the time of the Event in their boats;
- 3.3. The Member State shall enter its vessels into the water, where they shall be more comfortable and by water to he registration, detection, start, finish and closing;
- 3.4. During fishing, only two Participatn equipmentand their angling equipment, as well as an operator or a representative of theorganisers, if necessary, maybe present in thevessel;
- 3.5. On the day of theevent, each Membermust registerseparately for participation intheevent;
- 3.6. Member States aregranted an ID card, which must be carried with you throughout the Event;
- 3.7. The Participant shallbe free to choose the place to fish, subject to the aquatorium of the event and the restrictions imposed, as well as by assessing the condition of the boattechnician, technical capabilities and fuel stocks, with a calculation to take account of the timetable of the P-sharpness programme.
- 3.8. Photos of Included Fish aretaken and recorded by Mana Cope.

PROCEDURE OF THE EVENT S

1. DAY – 17 September

- 16:00-18:00 REGISTRATION The participant arrives at the place of the Start for registration with his vessel and one by one, without crowding, goes to theorganizers forregistration. Sign the minutes, receive the necessary details for the Cup and go back to your vessel and stick the start number receivedon it;
- **18:15 –** OPENING CEREMONY Participantswatch the opening ceremony from their vessels;
- 18:30 BOAT PARADE Member Statesgo on a boat parade in their vessels along the Riga City Canal -from Andrejosta Yacht Club to the Central Market. Participants areadvised to display their command/crew flag or otherwise decorate their boat, thusmaking the parade more magnificent. At the end oftheparade, the Participantgoes tohis sailingtothe places of the shed.

2. DAY – 18 September

- 08:00 -08:45 Crews arrive at the Venue just ai, are immediately in or go to their vesselsand are preparing to start. Boat inspection – Event organizers and assistants go to the crew and carry out boat inspection – check safety measures, fish storage tanks, as well as issue a unique sticker, without which the crew's result will not be counted;
- **08:45 08.55** Member Statesgo to the starting positions in the Daugava river nearAndrejosta in theirvessels;
- **9:00** Fishing starts judges begin to accept the results;
- 16:00 End of fishing judges no longer accept the results. Member Statesshall go to their places of shipping facilities;
- **18:00** Announcement of intermediate results online on My Cope and on the Event Facebook page.

3. DAY – 19 September

- 08:00 -08:45 Crews arrive at the Venue one by one, are immediately in or go to their vessels and are preparing to start. Boat inspection – Event organizers and assistants go to the crew and perform boat inspection – check safety measures, fish storage tanks, as well as issue a unique sticker, without which the result of the crew will not be counted;
- **08:45 08.55** Member Statesgo to the starting positions in the Daugava river nearAndrejosta in their vessels;
- **9:00** Fishing starts judges begin to accept the results;
- **16:00** End of fishing judges no longer accept the results. Participantsgo to the Venue, Andrejosta Yacht Club;
- **17:00** announcement of results online on My Cope and on the Event Facebook page;
- 17:00 17:15 Submission of claims;
- **17:30** 18:15 awarding ceremony, closing ceremony of theevent.

Results online 9:00 - 15:00 on My Cope

4. ROLE REGISTRATION

Catch role for registration:

- 4.1. Photos of the caught fish are taken by Membernieki from the site Mana **Cope** using a photo camera of a mobile device.
- 4.2. Theparticipants register each fish caught separately using my profile section of **My Cope** by selecting the Add *role* button in the Competition Catches *subsection*.
- 4.3. The participantshall take two photographs showing the left side of the fish:
 - 4.3.1. **The first** photo the fish is photographed on the measuring line assigned by the organizer, so that we can clearly seea:
 - 4.3.1.1. the whole fish the fish itself, the length of the fish and thefigures on the measuring inetal.
 - 4.3.1.2. zivs arefreely located on the measuringtable, the muzzle of the fish mustbe fully supported against the cut-off stop, the tail must be straight and present at the measuring line, but its ends are uncompressed together;
 - 4.3.1.3. Next to the measuring distance Membernieka, who caught the fish, ID card;
 - 4.3.2. **The second** photo the fish was taken together with the winner of the role and clearly visible on his Memberinieka ID card.
- 4.4. Photographs of the fish must be sent no later than 5 (five) minutes after the fish has been removed from the water.
- 4.5. Only two versions may be submitted for the photographs referred to in point 4.3, they may not be altered or others may be submitted. Accordingly, a maximum of 4 (four) photos may be added to the My Cope role.
- 4.6. The panel of judges shall have the right to request additional proof of authenticity of the role, the proof of which must be produced by the Member States in the video of the release of thefish. The video of the release of thefish must show the following actions the fish is freely on the tape measure, the fish is lifted from the tape measure and gently let into thewater, it can be seen that the fish is alive and drifts away.

5. EVALUATION OF RESULTS

Only live fish are accepted for assessment. Bloody, injured or dead fish are not accepted for evaluation.

Fish that do not meet the minimum size to be retained inthecatch must be immediately accurately released and released.

The following are assessed:

- 5.1. Pikes from 50 cm, pike perch from 45 cm, perch from 25 cm registered on the website Mana Cope, photographed and photos submitted in accordance with this regulation.
- 5.2. Fish lengthu according to the by-laws of the say judges after the sent role pictures.
- 5.3. The result of crew dingethey are calculated by summing the points for each centimetre of length of the 3 largest predatory fish of each of the following species: pike, pike perch, perch. I.e. 3 pikes, 3 pike perch, 3 perch;
- 5.4. From the points obtained from the crew, penalty points, if any, shall be subtracted and the result of the crew's day shall be calculated;
- 5.5. Registration of the length of the fish in the report must be carried out as follows:
 - 5.5.1. The length of the fish is fixed only in full centimeters, rounding upwards. For example, pike 51.2 cm, is registered as 52 cm, perch, 26.7 cm, is registered as 27 cm.
 - 5.5.2. Fish that do not meet the minimum size shall not be recorded in the report and rounding-off shall not be valid. For example, pike 49.90 cm is not considered to be pike 50 cm long.
- 5.6. Accordingly, placesaredividedbetweencrews. The location number on a given day consists of test balls, more points a higher place and fewer points.
- 5.7. In the case of equal points, the crew to which 9 fish are counted, if none, who caught the longest fish, if the size of the longest fish coincides, the most woven place shall be taken by the crew who caught the test fish closer to the end of the time given for fishing, if time coincides, a higher place is obtained by the crew who first caught the test fish.
- 5.8. The sum of the crew balls of both days makes up the crew's overall score, the less ball, the higher the place.
- 5.9. In the case of the sum of equal points, a higher position shall be taken by the crew counted as 18 fish, if none, for which the sum of the points for both days is greater, if the sum of the points is the same, the crew who caught the longest fish, if the size of the longest fish coincides, the most woven place is taken by the crew who caught the test fish closer to the end of the time given for fishing on the second day of the Cup, if the time coincides, who first caught and registered the test fish on the first day of the Cup, if these criteria are not enough to be decided by a panel of judges with the calculation that a higher place is obtained by the crew who has shown better skills,
- 5.10. The result of the Ekipage shall not be counted if the crew has not arrived at the Event, has notbeen included in the Cup or has been disqualified, it receives as many balls as the crews +1 in the Event on the relevant day.
- 5.11. The Panel of Judges reserves the right to specifythe fixed results on the basis of photographsof the fish sent by the Member State.

6. PENALTIES

All penalties, together with an explanation, will be published in Mana Cope. Three types of penalties canbe awarded for infringements: penalty points, yellow card, red card.

PENALTY POINTS:

- 6.1. For late registration 25 penalty points are awarded, or -25cm from the first day of the Cup ;
- 6.2. For failure to show up for boat inspection 50 penalty points are awarded, or -50cm from the respective day the catch and crew are not allowed to go fishing before the boat is inspected;
- 6.3. For delay of the start 15 penalty points and 5 points for each minute of delay are awarded, or -15cm and -5cm of the respective Cup day role, respectively;
- 6.4. For the loss of the measuring line 30 penalty points are awarded from the total result of the Cup;

YELLOW CARD:

Takinga yellow card for the crewin questioncancels the two longest fish from the Cup result and reduces the time allowed for fishing by 30 minutes. Crew d goldcard is awarded for the following violations during the Event:

- 6.5. (a) aggressive, dangerous driving, if this can be proved by one of theParticipants, or is recorded by the organiser. (a)a threat to otherParticipants, to the riders themselves or to third parties;
- 6.6. The crew shall not wear life jackets when travelling in the course of the vessel, if it can be proved by any of the Participants, or it shall be recorded by the organiser;
- 6.7. if any of its Participants, during the Event, by their actions, creates any dangerous, health-threatening situation for other Participants of the Event or third platforms;
- 6.8. if any of its Participants violates the provisions referred to in paragraph 2.13 of this Regulation and is disrespectful to the catch caught.
- 6.9. if any of its Participants intentionally pollute nature on land or water.
- 6.10. if any of its Members, the rules referred to in point 2.10 of the Statute and fails to comply with the requirements, instructions and decisions of the panel of judges.
- 6.11. if any of its Participants violates paragraphs 2.14 to 2.19 of this Regulation. For rough, inappropriate treatment of judges, organizers, other Participants and third parties.
- 6.12. if it violates paragraphs 2.20, 2.25 to 2.33 of this Regulation.

Two yellow cards automatically become a red card with a tulit disqualification from the Event.

SARCANA CARD:

The crew shall begiven an arcana card if two yellow cards have been received and for the following offences:

- 6.13. it has received a penalty from the municipal police for speeding or other violation of the regulations referred to in Paragraph 2.9 of this Regulation on the water during the time allotted for angling cup.
- 6.14. if eitheror both of its MemberStates violates paragraphs 2.11, 2.12, 2.2 1of this Regulation. Deliberate cheating is punished with life disqualification.

The red card gives the organisersthe rightto award crew members a multi-year or lifetime disqualification at events organised by the organisers .

7. DETERMINATION OF WINNERS

The highest place is taken by the crew with the smallest sum of the parties of both days.

AWARD CEREMONY

The organizer of the event awards theparticipants in the following categories:

- 7.1. place Cup winner/winner "Predator Cup 2021" Winner main prize, cup and medals
- 7.2. place prizes and medals
- 7.3. place prizes and medals
- 7.4. place prizes and medals
- 7.5. place prizes and medals
- 7.6. place prizes and medals

Fish:

The largest pike;

The largest perch;

The largest zander;

The most unsportsmanlike fish (any other fish that does not go within the meaning of this regulation, but is noteworthy and clinging to anartificial decoy). Such roles are sent into the Whatsapp group of the Event.

SURPRISE PRIZES

The most beautiful boat (the most beautiful, attractive boat, decorated with flags, or otherwise, participating in theparade);

Organizers can award various other surprise prizes at their discretion.

8. Protests

Protests are accepted in writing together with a confirmation of the deposit of 50.00 EUR (fifty euros and 00 cents) to the organizer's account, marked PCR21 Protest.

The protests are accepted within 15 minutes of the publication of the official Cup results. If the protest is granted, the security deposit is returned to the protestant, otherwise it is not returned.

9. advertisement

Advertising on Participatn'sclothing, shapes, hats, bags and cars is not prohibited. It is prohibited to place or distribute materials containing reklamaat the venue of theevent

in coordinationwith the organiser of the event.

Placing of a transport or vessel containing advertising in the area where the opening and award ceremony of the Event takes place, without co-ordination with the organiser of the event, is prohibited.

During the event or at the request of the event organiser or a panel of judges, the Membermust move its vehicle or vesselto a place specified for it.

10. SECURITY, DATA PROTECTION, FILMING AND PHOTO

By applying forthe Event, the Participantconfirms that the organizer may use the data transferred by him or her for his or her own purposes far as the organisation, conduct and reports of this Event are concerned.

By registering for the Event, MemberState confirms with its signature and agrees that:

- 10.1. his/her state of health, skills and abilities allow him to participate in the Event organised byBSM;
- 10.2. he/she is personally responsible for his safety, including by the water;
- 10.3. undertakes, by its actions, not to create conditions and to avoid action which presents another risk to safety or health;
- 10.4. authorises BSM and Mana Cope to publish in the press, on television and on the Internet photographs and videos of their names and photos and videos of the event in which the athletes arerecognisable;

- 10.5. does not object to the processing of metadata My Cope role at the time of registration;
- 10.6. is informed that the use of photographic, video or recorded audio material taken during an event organised by BSM for commercial purposes is prohibited without the written permission of BSM;

Event Participants:

P2.1. have been informed and undertake to comply with Regulation No. 360 of the M Inistru Cabinet of Ministers of 9 June 2020, "Epidemiological safety measures for the control of the spread of <u>COVID-19 infection</u>" (hereinafter referred to as Cabinet Regulation No. 360),the Law on the Management of the Spread of <u>COVID-19</u> Infection and the provisions of measures to limit the spread <u>of COVID-19</u> infection;

P2.2. Upon registration for the Event on the day of the Event, a certification shall be completed (Annex No. 3)

P2.3. are responsible for compliance with the specified restrictions and precautionary measures;

P2.4. do not come together within the framework of sharpness, observe a distance of 2 m and try to staywith or in their vessels for the maximum periodof time.

Rules and measures to limit the spread of infection During the event:

P2.5. The event is organized in semi-safe or yellow security mode, whichmeans ersons with an interoperablecertificate of oversuse or interoperable vaccination certificates, as well as persons with an interoperable testing certificate attesting that the person has performed a COVID-19 test in the last 48 hours for SARS-CoV-2 virus RNA, which is negative, or the SARS-CoV-2 antigen testcarried out within the last six hours isnegative.

P2.6. Control is ensured at the entrance of the Eventin order to identify the compliance of the persons present with the requirements referred to in paragraph P2.5 of this Regulation.

P2.7. The venue of the event shall be delimited in order to ensure that third parties cannot enter and are not present in theterritory of the event and persons who do not comply with the requirements referred to in Point P2.5;

P2.8. Sharpening ogranizers, judges and their assistants operating at the venue shall have an interoperable resuscitation certificate or interoperable vaccination certificates.

P2.9. Persons present at the event, upon request of a person appointed by the organiser or controlling authorities, shall present an interoperable certificate attesting to compliance with the requirements referred to in Paragraph P2.5 of this Regulation. Controlling authorities shall have the right to require the production of these certificates.

P2.10. The organiser of the event collects information about the Participants (given name, surname, contact phone number)which is stored for up to one monthand, if necessary, transmitted to the Centre for Disease Prevention and Control upon its request;

Article P2 11. Indications with information regarding the observance of distance shall be placed in a visible place at the entrance of the venue of the Event in the min. 2m., hygiene, self-isolation, quarantine, as well as other information in accordance with the Cabinet Regulation No. 360;

Article P2 12. At the venue, the organiser shall ensure the availability of appropriate hand sanitiser, as well as an indication with a reminder to perform hand hygiene and instructions for proper hand hygiene. Disinfectants are available to all those involved in the event;

Article P2 Article 13 The event is organised in such a way that no gatherings are formed and the Participant is presentat or in its vessels for most of the duration of the Event, thus keepingthe specified distance of 2m and not gathering.

Article P2 14. The flow of Member States to Registration is controlled, i.e. registration Memberngoes one byone, which is controlled by the representative of the organizers.

Article P2 15. During the inspection of vessels, the Member State shall be present in its sailing craft and shall waitfor the representative of the organiser to come to them and carry out theinspection.
